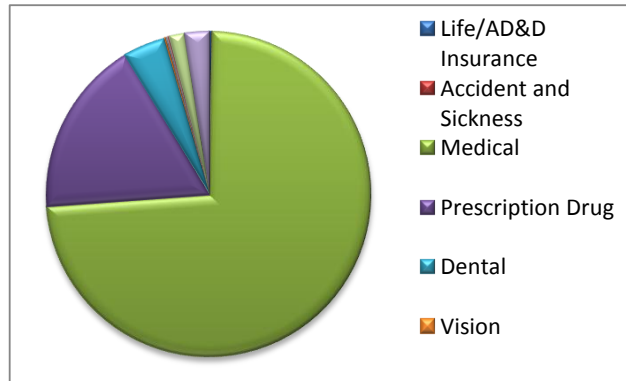

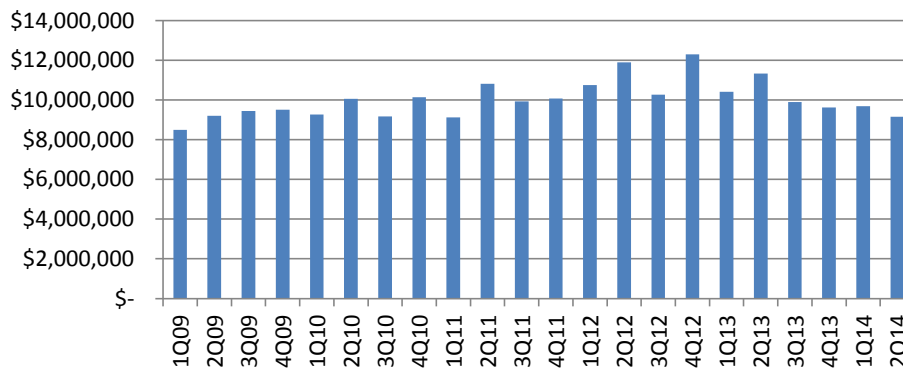

January 2014 - June 2014 Expense Data

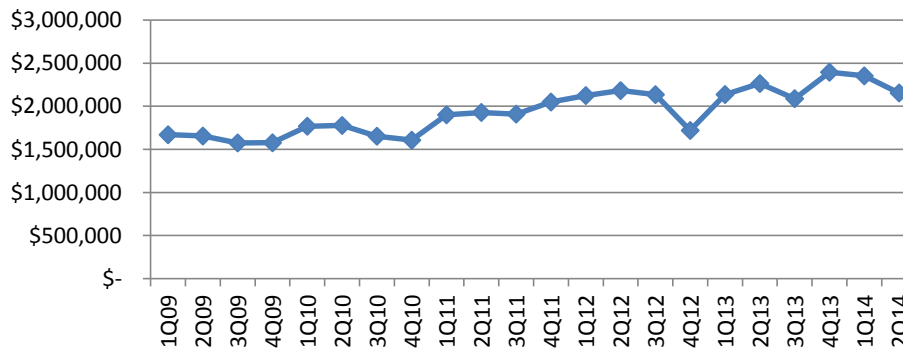

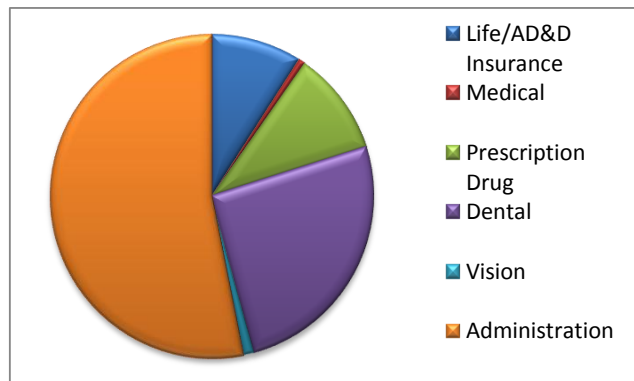


FT Prescription Drug



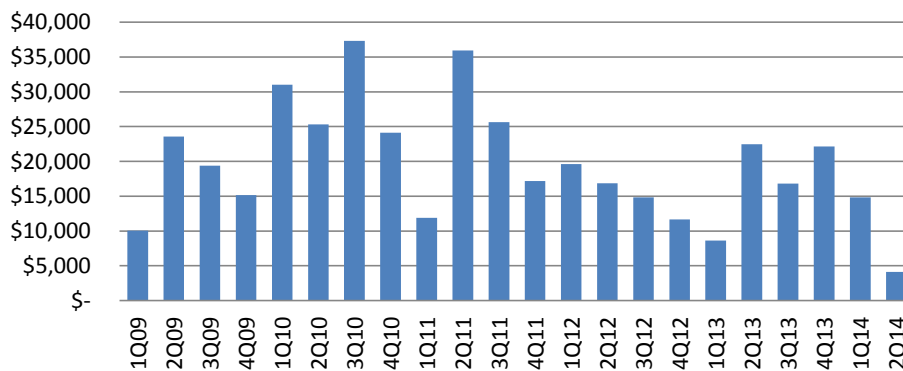

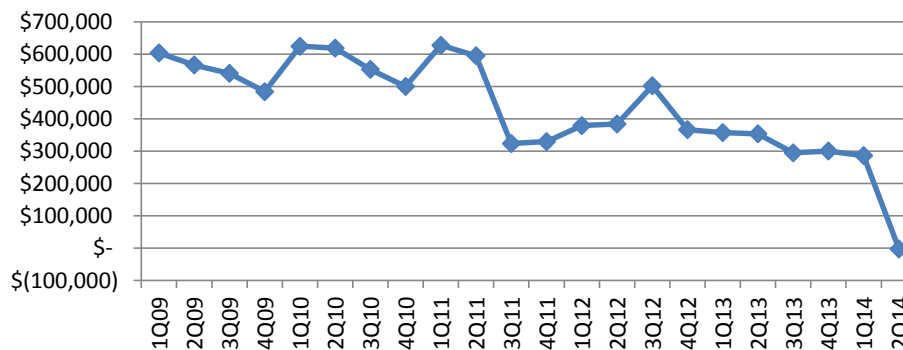

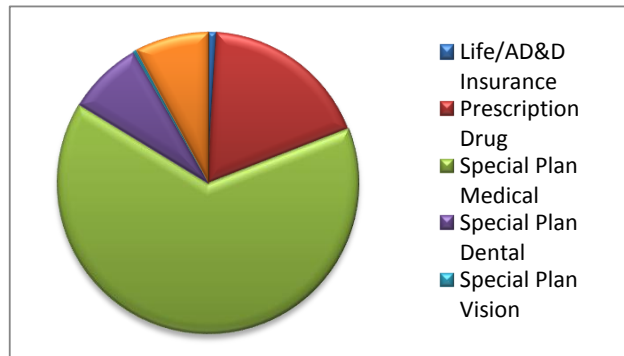
PT Prescription Drugs

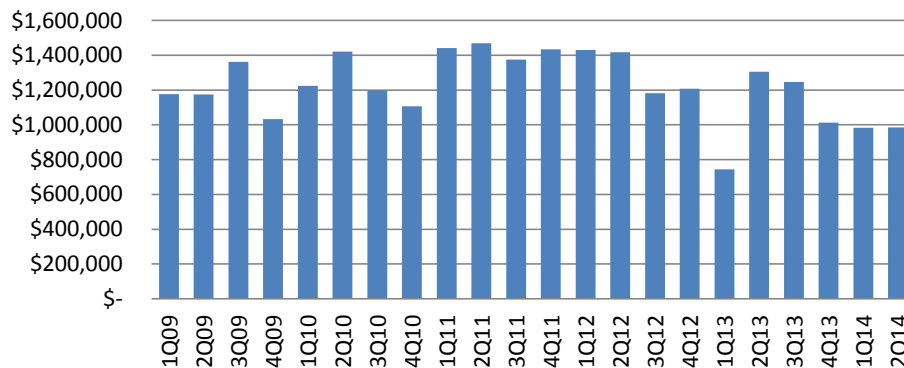

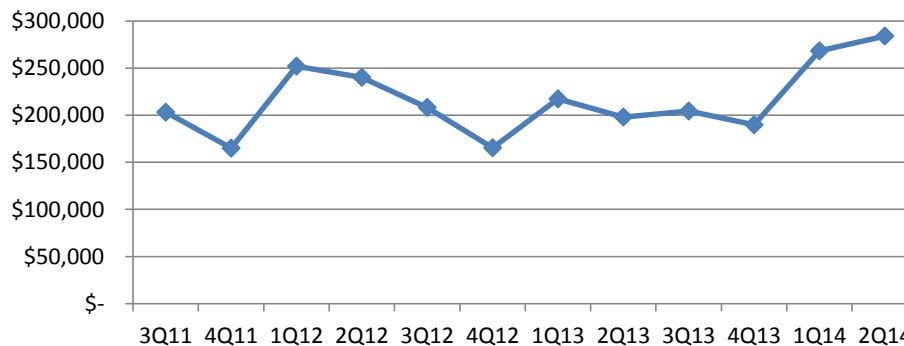

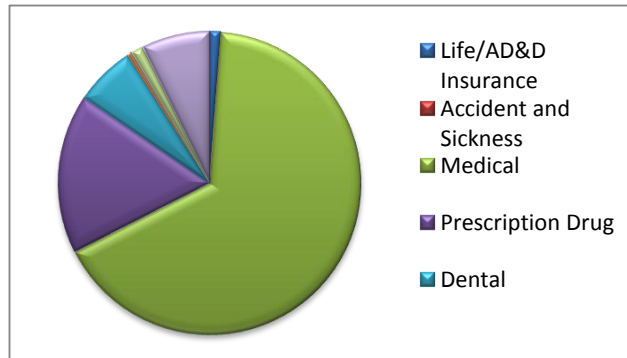

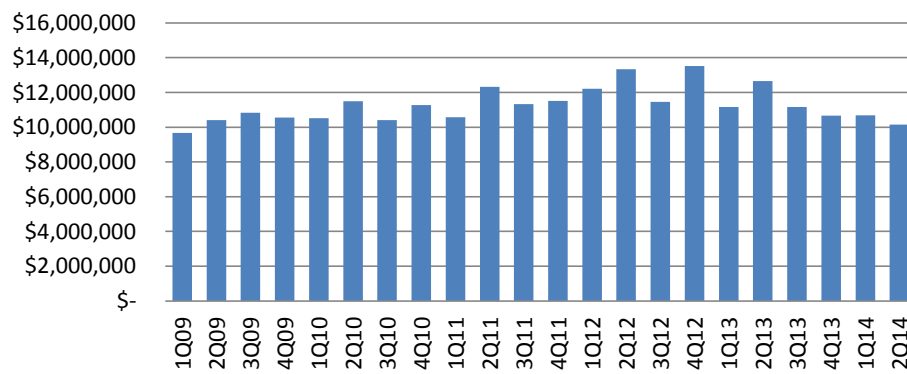

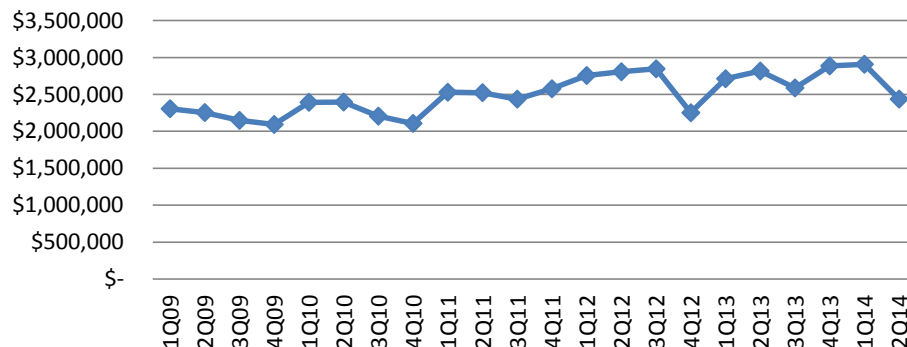
