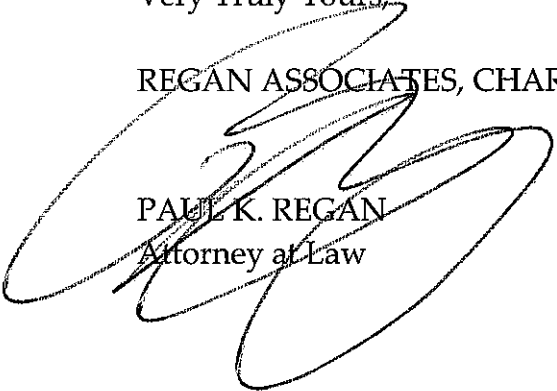
Enclosed is a copy of the utilization report for July, August and September 2013.
