2012 Summary Annual Report For WAREHOUSE EMPLOYEES UNION LOCAL No. 730 HEALTH AND WELFARE TRUST FUND

This is a summary of the annual report for the WAREHOUSE EMPLOYEES UNION LOCAL NO. 730 HEALTH AND WELFARE TRUST FUND, (Employer Identification No. 52-6058419, Plan No. 501) for the period January 1, 2012 to December 31, 2012. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan has contracts with Reliastar Life Insurance Company to pay certain life insurance and Accidental Death and Dismemberment insurance; Optimum Choice/United Healthcare to pay HMO medical claims and certain prescription drug benefits; Fidelity Security Life Insurance (Group Vision Services) for certain optical benefits; and Connecticut General Life Insurance Company (CIGNA) for access to the PPO network. The total premiums paid for the plan year ending on December 31, 2012 were \$1,627,086.

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtraction of the liabilities of the plan, was \$16,897,490 as of December 31, 2012 compared to \$19,196,947 as of January 1, 2012. During the plan year, the plan experienced a decrease in its net assets of \$2,299,457. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$7,279,164. This income included employer contributions of \$5,092,956, employee contributions of \$622,519, earnings on investments of \$833,515, and other income of \$730,174. Plan expenses were \$9,578,621. These expenses included \$411,981 in administrative expenses and \$9,166,640 in benefits paid to participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
