This is a summary of the annual report for the Trustees of the WAREHOUSE EMPLOYEES UNION LOCAL NO. 730 & CONTRIBUTING COMPANIES' PREPAID LEGAL SERVICES FUND (Employer Identification No. 22-3408915, Plan No. 501) for the period January 1, 2015 to December 31, 2015. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was \$819,120 as of December 31, 2015 compared to \$800,906 as of January 1, 2015. During the plan year, the plan experienced an increase in its net assets of \$18,214. During the plan year, the plan had total income of \$159,238. This income included employer contributions of \$151,822, realized losses of \$1,610 from the sale of assets and earnings from investments of \$9,026. Plan expenses were \$141,024. These expenses included \$58,277 in administrative expenses and \$82,747 in benefits paid to participants and beneficiaries.
