2017 SUMMARY ANNUAL REPORT

FOR

WAREHOUSE EMPLOYEES UNION LOCAL No. 730 HEALTH AND WELFARE TRUST FUND

This is a summary of the annual report for the WAREHOUSE EMPLOYEES UNION LOCAL NO. 730 HEALTH AND WELFARE TRUST FUND, (Employer Identification No. 52-6058419, Plan No. 501) for the period January 1, 2017 to December 31, 2017. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan has contracts with ReliaStar Life Insurance Company to pay certain life insurance and Accidental Death and Dismemberment insurance; Optimum Choice/United Healthcare to pay HMO medical claims and certain prescription drug benefits; Fidelity Security Life Insurance (Group Vision Services) for certain optical benefits; Union Labor Life Insurance Company for stop loss coverage. The total premiums paid for the plan year ending on December 31, 2017 were \$791,455.

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtraction of the liabilities of the plan, was \$7,076,515 as of December 31, 2017 compared to \$6,857,581 as of January 1, 2017. During the plan year, the plan experienced an increase in its net assets of \$218,934. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$4,680,310. This income included employer contributions of \$4,435,699, employee contributions of \$8,778, realized losses of \$77,390 from the sale of assets and earnings from investments of \$313,223. Plan expenses were \$4,461,376. These expenses included \$378,062 in administrative expenses and \$4,083,314 in benefits paid to participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
